

Belle Vita Blooms Wedding Consultation/Contract Form

WEDDING CONTRACT

Belle Vita Blooms reserves the right to cancel this contract if at any time we feel that the obligations cannot be met. In the event of fire, natural disaster, tragedy or other emergency, liability is limited to full refund of all monies paid, not including consultation fees.

Terms: Payments must be in Cash, Credit Card, Check or Money Order. A deposit of 1/3 the price is required for confirmation of Wedding Date. First Deposit is non-refundable. Balance due must be paid in Full 14 days before your Wedding Date.

First deposit is due 2 weeks after you receive your estimate.

Consultations are available by appointment for a fee of \$27.06, payable at time of service. The fee of \$27.06 will go towards your final totals if you decide to use our services. The Consultation Fee includes 1 hour of time and 1 Estimate/Contract. Minor Changes to the initial Estimate/Contract, 5 phone conversations, and 10 e-mail correspondences. If you decide to make major changes to your wedding flowers and need more time than allotted for (in the previous sentence), you will be charged \$15.00 per hour for time. The extra incurred fees will not go towards your final totals. If you decide to cancel your wedding, the fee of \$27.06 and any other incurred fees will NOT be refunded.

Additional Floral Selections will be accepted up to two weeks prior to Wedding Date. No guarantee is given that the same flowers will be available on additions made less than two weeks prior to wedding. Color and style will match as close as possible.

Cancellations: We understand this is a custom order and understand if payment is not made in Full 14 days before your wedding date, this contract is canceled and all payments are forfeited. Contract cancellation must be in writing. Cancellations made prior to final time allotment of 14 days before your wedding date will receive a refund on monies paid, less non-refundable deposit and consultation fees.

Substitutions: We reserve the right to make substitutions in the event the flowers received are not of the quality suitable for your wedding/event. In this event, the integrity of the proposed color scheme will be maintained and flowers of equivalent value will be used. Example: Pink Wax Flower is ordered as a filler flower for bouquets, but weather conditions cause unavailability or poor quality. Pink Heather or a similar filler would be used. Red Roses would Not be a substitute for White Orchids.

If we do have to substitute, we will call you and let you know of the situation.

Rentals: All rentals are to be returned by 10:00 a.m. the Monday after your Wedding/Event. Rental Items need to be returned on time and in the same condition they were when you rented them or you will be charged a late fee and/or damage fee. Do NOT use Tape, Staples, Nails, Screws, Oil, or any type of Glue on any of our Rental Items.
